EXPRESSION OF INTEREST FOR EMPANELMENT OF FABRICATORS FOR FABRICATION, INSTALLATION AND COMMISSIONING OF STAINLESS STEEL / MILD STEEL ESSENTIAL OIL DISTILLATION UNITS AS PER DESIGNS AND SPECIFICATIONS OF CSIR-CIMAP

TERMS & CONDITIONS

1. The empanelment of fabricators is to be made for supply, installation, testing and commissioning of various type of distillation units at various places of country as per the requirement of CSIR-CIMAP Lucknow.
 - The majority of distillation units to be fabricated & installed includes directly fired type field distillation units of 500 Kg capacity. Other units to be fabricated based on crop requirements will include SS cohabation type units of 500 Kg capacity and boiler operated steam distillation units of up to 1000 Kg.
 - Major regions/states where units have to be installed includes Maharashtra (Vidharbha), UP (Bundelkhand), Bihar, Rajasthan, Gujrat, Orissa, Karnataka, Tamilnadu, Telangana, North East states.
2. The fabricators interested for empanelment are requested to submit complete profile alongwith technical literature/broachers, copy of registration with various authorities, work performed certificated, copy of executed supply orders etc in a sealed envelope super scribing “**EXPRESSION OF INTEREST FOR EMPANELMENT OF FABRICATORS**” addressed to The Director, CSIR-Central Institute of Medicinal and Aromatic Plants, PO CIMAP, Kukrail Picnic Spot Road, Lucknow-226015 and should necessarily be reached to this office on or before **1.00PM on 06.11.2017** All the received interests will be opened on **06.11.2017 at 2.30 PM**.
3. CSIR –CIMAP will invite techno-commercial quotations from empanelled fabricators for finalization of parallel rate contract for a period of one year for supply installation and commissioning of distillation units as per the requirement.
4. The fabricator should have registration for GST registration and attested copy of same may be attached.
5. The fabricator should have registration on Central Public Procurement Portal (CPPP-www.etenders.gov.in), copy of registration / user ID may be attached for empanelment on portal.
6. The fabricator should have valid PAN. The copy of PAN card may be attached.
7. The Fabricator should have experience in fabrication of steam distillation units / extraction plants/ chemical process equipments like heat exchangers, reactors etc. Supporting documents / order copies of fabrication and supply of such units to government or industries to be attached.
8. The Fabricator should have fabrication workshop having modern tools & equipments like argon welding, arc welding, plate bending machine, lathe machines, buffing & polishing tools etc. List of facilities to be attached.
9. The fabricators will have to fabricate the distillation units strictly on the basis of designs and specifications given by CSIR-CIMAP. Any changes / deviations to be approved by CIMAP
10. The Fabricators will have to arrange for the transportation & installation of the distillation units at the sites including loading/unloading, piping, civil materials, construction of furnaces, labor costs etc
11. The Fabricators have to give one year onsite warranty on all distillation units to be fabricated by them
12. The Fabricators will sign an MOU with CSIR-CIMAP and will have to submit an undertaking of not reproducing the designs or fabricating similar units or using the drawings / specs / photographs of the unit for any other purpose whatsoever.
13. CSIR-CIMAP will have the discretion of accepting / rejecting the firms based on above T&C.
