Therefore, there is a great need to understand the process of herbal drug development and the technologies used for this purpose. This five days residential training program will help the students/researchers/faculty members and industry persons to understand the basic concept of herbal drug development, pharmacognostic evaluation, chemical characterization of plant extracts and essential oil, *in-vitro* and *in-vivo* evaluation of herbal drugs, and Ayurvedic as well as pharmaceutical formulations.

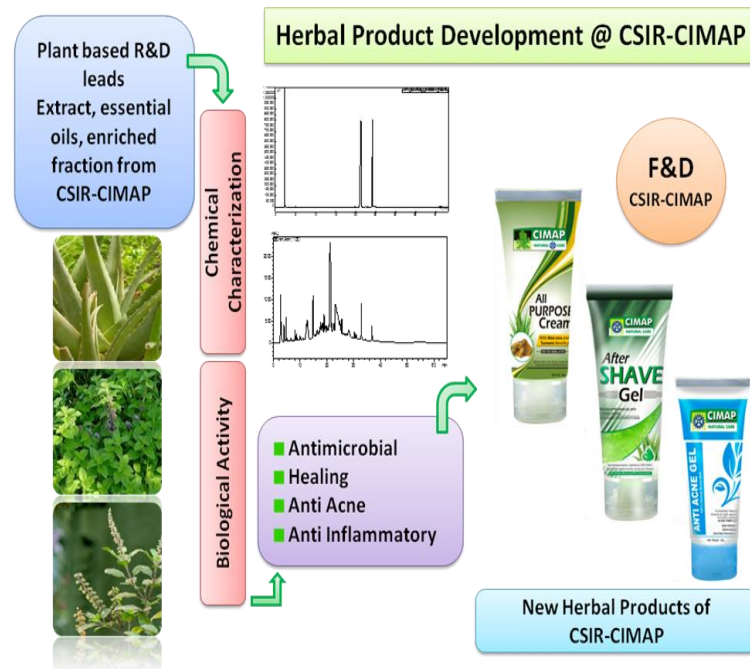
