- 1. Period of engagement of Consultant:** Consultant will be appointed on temporary (non official) basis and the appointment may **be cancelled, at any time by CSIR-CIMAP**, without assigning any reason whatsoever by giving one month notice. Initial appointment will be for **one year**(Co-terminus with the project) and may be renewed on the basis of performance evaluation.
- 2. AGE- LIMIT :** The maximum age limit of Consultants will generally be 65 years during the period of their engagement.
- 3. Procedure for selection of Consultants:** On the basis of the information furnished by the Applicants, shortlisted candidates would be called for personal interview. The Consultant will be selected on the basis of interview conducted by a Board.
- 4. An agreement will be required to be signed by the Consultant.**
- 5. The Consultancy will not entitle the concerned person to any claim of Government service and/ or CSIR service, in any manner**

6. General conditions for engaging Consultant:

1. The selected person should be ready to serve at any of the offices/Research Centers of CSIR-CIMAP located at Lucknow, Bangalore, Hyderabad, Pantnagar, Purara (Distt. Bageshwar) or at any place of posting in India as per need of CSIR-CIMAP R&D activities.
1. The period of experience in the requisite discipline/area of work wherever prescribed, shall be counted with effect from the date of acquiring the prescribed minimum educational qualifications required for the post.
2. The cutoff date for determining the qualification, age and experience of a candidate will be last date of receipt of applications.
3. Mere fulfillment of essential educational qualifications & experience does not entitle a candidate to be called for Interview. The decision of CSIR-CIMAP/ CSIR in all matters relating to eligibility, acceptance or rejection of applications, mode of selection and conduct of interview will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection from any candidate.
