Terms and Conditions:

1. For Project Associate Level- I the upper age limit as mentioned for the above position will be as on date of interview (**7th January 2022; Reporting time between 9.00 AM to 10.00 A.M.**). The age is relaxable up to 05 years in the case of candidates belonging to Scheduled Caste/ Scheduled Tribes/Persons with disabilities and OBC candidates.
2. Special age relation in case of Widows, Divorced women and women judicially separated from their husbands, who are not remarried as per rules.
3. Engagement will be initially for one year, and may be extended or curtailed depending upon the project requirement, and desired level performance or conduct of the incumbent, as the case may be.
4. The tenure of project staff shall be co-terminated with the project. However, under no circumstances the tenure would be allowed to exceed five-year duration. The performance of the Project Staff would be reviewed periodically so that anyone not found up to the mark, could be terminated.
